

### YUCAIPA'S "WING SING GARDEN" AND ITS CHINESE OWNERS

This photo was taken from a map drawn in 1903 by civil engineer, C.C. Brown to record the drainages of the Yucaipa Valley. Dike and Logie formed the Redlands-Yucaipa Land Company and the map was preliminary work for that company. China Gardens is noted on the map.

The area today would be between Yucaipa Blvd. and "E" Street to the south. "Chicken Hill" is southeast and today marks the location of Oak Glen Road and Avenue "E." Chicken Hill became a landmark after a wagon load of chickens fell off on a steep curve. Evidently many of the chickens were not caught and remained wild along that stretch of the road for years. Maude A. Fox wrote *Both Sides of the Mountain* in 1954 and wrote about Chicken Hill in the book.



China Gardens. (Wing Sing Garden)

Yow Kee Wong Nom Wong Chun Foo Wong Yan Wong Yuk (Yup) Yup Sim

- Yow Kee is 35 years old, a gardener, 137 pounds, and a resident of Redlands on Aug. 20, 1897. His garden is 100 acres with 10 partners in Yucaipa and he's lived there 3 years. He has been in the United States for 19 years. He paid \$10 an acre for the land. He raises vegetables and sells in Redlands both retail and wholesale. He owns \$3000 in property.
- Wong Nom lives in Yucaipa as a gardener and has \$600 in property. He is one of 10 partners in the Wing Sing Garden in Dunlap.
- Wong Chun Foo is 39 years old and lives in Redlands as a gardener. The garden is the 100-acre Wing Sing Garden in Yucaipa. The vegetable garden sells by vendor three times a week in Redlands. He is worth \$1800.
- Wong Yan is a vegetable gardener in both San Bernardino and a shareholder gardener in Yucaipa. The Waterman Garden is called the Mow Sang Garden.
- Wong Yuk is 38 years old, five-feet, seven inches tall and resident of Redlands. He resides in the garden of Yucaipa the last two years.
- Yup Sim has lived in Redlands 8 years. He lived six years in San Bernardino before moving to Redlands. He has been part of the Yucaipa Garden for one year and paid \$650 for a share.

County of San Bernardino documents record Chinese laborers as early as 1853 working on the various zanjas of the valley and working in agriculture. The Geary Act, passed in 1892, required the Treasury Department to complete applications for returning Chinese to China. The point of the act was to make sure the returning Chinese left no debts here before their return to China. Each application required a photograph, physical description and financial record of the applicant with at least two American citizens swearing to the information given. These Federal records are on file with the National Archives in Perris, California under the Los Angeles District Office under Chinese case files 1893-1935, boxes 4, 6,13, 14, 18, 22, 23 and 24.
